On Thursday, February 23, 2023, I, Lt. Kelvin Raven, received a text from Cpl. Sierra Randle advising she needed to speak with me and stated it was urgent. Because I was in a meeting at Hohlt Park, I requested Randle meet me at Hohlt Park.

Upon Randle's arrival, Randle stated [REDACTED] shared some information with her that took place while [REDACTED] was in field training in 2018. [REDACTED] told Randle Cpl. David Duddenhoeffer exposed his penis and testicles in the patrol unit while [REDACTED] was driving. Randle stated Duddenhoeffer said, "he had big balls" and wanted her to touch his testicles. [REDACTED] did not know the exact date but could find the date in her field training book due to a significant call that night.

I met with [REDACTED] and retrieved her field training documents for phase 3. [REDACTED] confirmed the date of April 19, 2018. [REDACTED] told me years later that Duddenhoeffer did apologize for what happened that night. It should be noted [REDACTED] last name was [REDACTED] in 2018. [REDACTED] third-phase field training documents are attached with his narrative.
